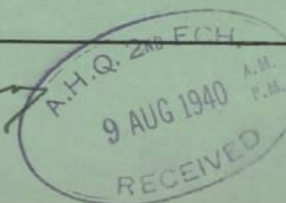

- (i) Real Estate, (ii) Land held under any lease or licence, (iii) Crops, (iv) Live Stock, (v) Farming Implements, (vi) Motor Vehicles, Carriages, etc., (vii) Harness and Saddlery, (viii) Furniture and Household Effects, (ix) Watches, Trinkets, Jewellery, (x) Pension, (xi) Money in hand or house, (xii) Money in Bank on Current Account, (xiii) Money in Bank on Deposit, including Savings Bank deposits, (xiv) Debentures, (xv) Bonds, (xvi) Shares, (xvii) Mortgages, (xviii) Life Assurance Policies, (xix) Plant, (xx) Tools of Trade, (xxi) Debts due to the Prisoner of War (set out names and addresses of each person owing the money and the amount of each debt opposite thereto), (xxii) Interest in a partnership or business, (xxiii) Stock in a shop or business, (xxiv) Interest in a deceased person's estate, (xxv) Any other personal property.

(2) Except in the case of debts due to the prisoner of war or internnee and money in hand or bank no values need be set out.

(3) Assets should be sufficiently described to enable them to be readily identifiable. When no assets fall under a particular head there is no need to refer to that head.

**Motor Vehicle.** 1 Empire Sedan (1928 Model), Registered No. 2222.

**Furniture and household effects.** 1 blackwood dining room suite, 1 oak bedroom suite, 1 5-valve "wireless set."
